Note:

The following transactions shall not be permitted:

- Cash withdrawals within the Republic of Uzbekistan
 - Cashless transfers from a card account upon the cardholder's instruction
 - Cash deposits into a card account
 - Payment of wages and equivalent payments under salary project agreements with enterprises
 - Other crediting of funds to a card account, excluding refunds from retail and service enterprises and erroneous debits
- Upgrade to Visa Platinum Business UZS/USD (The service is provided at the initiative of the bank for existing clients, using corporate cards Uzcard or Visa Business, subject to the condition of having a turnover on existing cards for payment of goods and services of more than 10,000,000 UZ Soums or 1,000 US dollars per month for 3 months).
- Monthly fee for use of cash registers and/or POS terminals of Kapitalbank JSCB, assigned for temporary use: 100,000 UZ Soums per month for 1 cash register and/or POS terminal with a turnover of up to 50,000,000 UZ Soums. For amount above UZS 50 000 000 the fee is not charged.
- * When converting one client's foreign currency into another foreign currency, the cross rate is provided by the bank based on the supply and demand of the external foreign exchange market.
- The bank's commission fee, including fees of foreign banks charged to the accounts of clients of Kapitalbank JSCB, are charged in national currency at the exchange rate of the Central Bank of the Republic of Uzbekistan on the date of the transaction, unless otherwise agreed.
- Immediate payments in foreign currency are payment orders from clients using conversion funds, accepted by the bank after 2:00 p.m. and executed on the current business day.
 - If there is no transaction on the account during a calendar month, the account maintenance fee for that month is not charged or collected.
 - When legal entities and non-legal entities (regardless of the form of ownership), as well as unincorporated private entrepreneurs, pay taxes and other mandatory payments to the State Budget of the Republic of Uzbekistan.
 - When clients request a revision of the terms of their tariff plan, no fee is charged.
 - The cost of bank services in these Tariffs is indicated excluding VAT.
 - From the moment the Parties sign these Bank Tariffs, the previous tariffs become invalid.
 - RCV - Reference Calculation Value.
 - Payment for the Bank's services not specified in these Tariffs is made in accordance with the Supplements to the Tariffs of "Kapitalbank" JSCB published on the Bank's official website
